Nevada Power – \$15 connection fee. Deposits depend upon credit check. If required, it can be waived with a Letter of Credit from your current utility company. Proof of ownership may be required. Phone number (702) 367-5555

Southwest Gas - \$25 connection fee. \$55 deposit can be waived with a Letter of Credit from current utility company. Fax to (702) 365-2354, Attn: Credit Desk

Las Vegas Valley Water District - \$100 deposit can be waived with Letter of Credit from current utility company. Fax to (702) 258-7165, Attn: Credit Dept. Phone number (702) 870-4194

City of Henderson Water - Deposit may be required. Sewer is included. Copy of lease agreement is required for renters. Phone number (702) 267-5900.

City of North Las Vegas - Proof of ownership is required. City of North Las Vegas bills for water, sewer and garbage. Renters must go into office with \$150 deposit. Phone number (702) 633-1484

Sprint Local Phone Service - \$55 connection fee. If field work is needed the connection fee is \$95. Each additional phone line has a \$35 connection charge. DSL activation charge is \$49.99. Additional fees for jack work. *All connection charges can be split over the 1st 3 billing cycles. \$25 deposit may be required.

Republic Disposal – Garbage fees are \$33.65 per quarter. Garbage is picked up twice weekly. Days vary depending on address.
